It is declared that there was no error of law under Section 10 of the Oil Palm Industry Corporation Act or any other law in relation to the decision of the first defendant of 23rd April 2020, published in National Gazette No: G227 of 24th April 2020, arising from the alleged errors of law referred to in grounds of review (c) and (d) in the further amended Order 16, Rule 3(2) (a) statement filed 29th April 2020, in that part of the decision of the first defendant that revoked the appointment of the second plaintiff as Chairman of the first plaintiff.

3. It is declared that there was an error of law under Section 10 of the Oil Palm Industry Corporation Act in relation to the decision of the first defendant of 23rd April 2020, published in National Gazette No: G227 of 24th April 2020, arising from the alleged errors of

law referred to in ground of review {c) in the further amended Order 16, Rule 3(2)(a) statement filed 29th April 2020, in that part of the decision of the first defendant that appointed the third defendant as Acting Chairman of the first plaintiff, and accordingly it is ordered that, that part of the decision of 23rd April 2020 is removed into the National Court and is the subject of an order in the nature of certiorari and is, with effect from 12 midday on 10th August 2020, quashed.

4. It is declared for the avoidance of doubt that the second plaintiff's appointment as Chairman of the first plaintiff has been lawfully terminated by virtue of the first defendant's decision of 23rd April 2020, published in National Gazette No: G227 of 24th April 2020, but that the second plaintiff's appointment as a member of the first plaintiff has not been terminated.

5. It is ordered pursuant to Section 155(4) of the Constitution that the Deputy Chairman of the first plaintiff shall for all intents and purposes be the Acting Chairman of the first plaintiff, with effect from 12 midday on 10th August 2020, until a substantive appointment is made in accordance with Section 10(1) of the Oil Palm Industry Corporation Act, and in the event that the Deputy Chairman is unavailable or unable to act as Chairman, the member of the Board with the longest period of service shall by virtue of this order be the Acting Chairman; and for the purpose of appointing a substantive Chairman, the members of the first plaintiff shall within 14 days after the date of this order, recommend to the first defendant that one of them, apart from the second plaintiff, be appointed as Chairman, and within seven days after receipt of that recommendation, the first defendant shall appoint the Chairman.

6. It is ordered pursuant to Section 155(4) of the Constitution that the third plaintiff shall continue, in accordance with the order of 7th May 2020, to be regarded for all intents and purposes as Acting General Secretary of the Oil Palm Industry Corporation, until a substantive appointment is made in accordance with Section 17 of the Oil Palm Industry Corporation Act and the Regulatory Statutory Authorities (Appointment to Certain Offices) Act 2004; and for that purpose the first plaintiff shall within 14 days after the date of this order, under Section 4 of the Regulatory Statutory Authorities (Appointment to Certain Offices) Act, declare the office of General Secretary vacant and advertise the vacancy and invite applications for appointment to that office and take all steps necessary to ensure that a substantive

appointment is made as soon as is practicable.
