RAINBO PAITA, MP, Minister for Finance, pursuant to Section 15 of the Public Finance (Management) Act, 1995: Approval & Establishment 1. Approve the establishment of a Trust Account to be known by the name stated in Point 1 of the attached Trust Account Schedule and hereby establish the Trust Account by the execution of this Trust Instrument, which has been approved by the State Solicitor, that specifies the operational terms and conditions of the Trust Account. 2.
